School will not be responsible for anything including misconduct/ misbehavior/safety etc. before or after school timings and out of school premises.

In case, a phone number is changed it is parents responsibility to give in writing to the school the changed phone number, the school will not be responsible.

The school will not be responsible for any obnoxious social media activities or online behaviour of the students and any tarnishing of school name in the social media by particular student and any personal post on social media that is unacceptable in terms of societal acceptance will lead to disciplinary action.
